1. Introduction

Practitioners are transformation collaborators in the true sense of the word. They represent people who want to practice their art. They are not content with only 'knowing.' They want to be 'doing.'

Practitioners refer to two groups of people. The first group sees themselves in a private-practice or a role in an organisation, church, or school dedicated to their practice. This relates to being remunerated on some level. Almost all helping professions require supervision at any level (up to PhD) and the Coram Deo programme offers exactly that. Do it once formally and then remain in the 'practitioner-collective' at only a nominal fee per year to continually adhere to the requirements that professional associations set.

The second group might not be that interested in asking a fee, but they nevertheless are passionate about what they have learned and commit to doing (practicing) their art in everyday situations. They may well consider setting up a professional practice at some stage and by then they will be ready to embrace the journey.

2. Different learning tracks and commencement

For those interested in registering, the first thing to consider (though it can be decided later) is that prospective members have an option to do the *combined programme* (advised) or *either* the supervision or CPD aspect of the combined programme.

Supervision meetups take the form of a near weekly schedule while CPD takes the form of attending four weekend online short courses. Supervision classes commence during the first or second week of February on the day mentioned in this document and to be communicated via email and other platforms to registered students.

The practitioner supervision community/students (for Pretoria and online) usually meet on Wednesday mornings 10:00-12:00 (in-person or online) and Wednesday evenings (online). Classes are scheduled to commence 12 February.

The CPD section covers four important additional university recognised short courses during the first year of supervision. These are aimed mostly at pastoral narrative therapists although other interesting topics are also dealt with from time to time.

The CPD 2025 topics

- 7-8 March: Medical and psychological discourses (in conversation with narrative and pastoral perspectives)
- 30-31 May: Faith in counselling
- 15-16 August: Making meaning with teens
- 17-18 October: Family-related topic

For students coming through the two-year pastoral narrative therapy programme at Coram Deo, the combined programme is seen as the third year of studies and offers the most value. Though, we have found most students choose to do the supervision component over two years.

3. Duration

The supervision programme can be done in a year, but most choose to complete it over two years and it is also what we suggest. The only implication for adding a second year or even completing in three or more years is that a reregistration fee is charged. Yet simply paying a reregistration fee which can be divided into small monthly payments is a cost-effective way to remain in the practitioner community even after completing the formal requirements. This is important since ongoing supervision is a requirement of most professional associations. Students may want to do this to remain a part of the practitioner-collective on an ongoing basis, using it as a peer- practitioner support structure under mentorship of senior practitioners at Coram Deo.

4. Requirements and benefits

- 45 hours role/counselling required conversations (Coram Deo does not offer the clients but do work towards creating opportunities throughout the year);
- 10 one on one supervision meetings with postgraduated or otherwise approved mentors/counsellors. There is some scope to use a supervisor not on our list if they agree to some terms and conditions. Three of the ten sessions should be with Dr Jo Viljoen (coramdeo.co.za/jo-viljoen);
- Be part of a peer learning community that encourages you on your practitioner journey and meets between 18-22 times during the year (in-person or online);
- A file is compiled (which becomes your portfolio) that is at moderated by the University of Pretoria
 that contains transcripts of several counselling sessions and supervisor feedback. A video recording of a
 few minutes is encouraged of one of the sessions (of you, not the client which often leads to
 discussions of identity, empathy and more);
- Recognition by the University of Pretoria;
- Facilitated from a narrative perspective;
- Allowing for spirituality or faith-based conversations where your views are respected;
- A community that speaks to the inherent loneliness of leaders and other professional roles
- Becoming more mindful about what makes you a better and balanced practitioner;
- Offers a reflective learning space for challenges practitioners might experience;
- Recognised by relevant professional associations;
- Access to the supervision community after the formal programme at a reduced fee in order fulfil
 requirements that your profession might set for ongoing supervision.

5. Finances

5.1. Payment options

Easy payment options are available especially if deciding to complete the programme over two years. Supervision generally offers the following in terms of requirements and benefits.

5.2. Cost of tuition

An initiation fee (registration fee) is payable with registration. The registration fee is already part of the deposit. The deposit is part of the total cost of tuition.

5.2.1. Registration fees

A registration fee is payable when filling out the registration form and is part of the full deposit payable by the end of January. In some instances, if registration takes place close to commencement students can simply pay the full deposit without deducting the registration fee.

There is a non-refundable registration fee of R420 for those still deciding on which programme (combined, only supervision or only CPD) to enroll for. 5.2.2. Full deposit

The specific registration fee (if paid already) can be deducted from the larger non-refundable specific deposit (see table below). Students who register closer to commencement must pay the specific deposit below (in which the registration fee is included).

Students may naturally wish to pay the full deposit from the beginning instead of first paying a registration fee. The full deposit is payable by end of January. The fee, though non-refundable, is transferable in the same year to another student or another programme but cannot be carried over.

If not used for tuition, the non-refundable deposit is treated internally as a donation towards our advocacy and counselling work in respect of addressing matters of abuse, dependency, trauma and more. This amount can then be deducted from your tax obligation when we issue, on your request, an Article 18A tax deduction certificate.

The following table sets out the different options.

5.2.3. Table of tuition costs

To simplify the financial data, the table is based on our suggestion to enroll for the combined practitioner programme and completing over two years. After the full deposit is paid (R2,290 in January) students will only need ot pay R746 per month up to November of the second year of studies.

Note – CPD tuition: Students enrolled for supervision (as separate) still receive discount on single CPD short course enrollment. They will pay R1500 instead of the public fee of R1,900 per course. But enrolling for any of the full programmes (the combined practitioner programme) involve significant savings during the programmes and special pricing benefits after completion.

5.3. Special benefits after completion of any full programme

(Full programmes include Pastoral Narrative Therapy course, Combined Practitioner Programme, Full CPD series, Supervision programme as separate track)

The following special community rates (Community Based Offers) are only available to students who **completed any of the programmes in full**. The offer is a type of community membership aimed at lifelong practitioner support in Coram Deo as a community of knowledge and practice.

So, after each programme students can do the entire programme again, and again, and again for a low 'community membership rate.' The programmes also change so this reduced membership will allow students to stay up to date, continue to learn and get support as a practitioner. In addition, members also get to attend third-party training from trusted lecturers who offer additional courses at reduced rates. Note than membership requires authorisation of monthly contributions via our DebiCheck bank platform. Alternatively make an arrangement with the financial office.

^{*} For students who completed the two-year Pastoral Narrative Therapy programme, if they sign up to be a Seeds-of-Hope contributing member at R500 per month they can redo any of the modules of the Pastoral Narrative Therapy programme (or the entire programme) for as many years as their donation remains intact. What's more is that since it is a donation the entire annual contribution of R6,000 can be subtracted from your tax obligation. If you combine this with a membership from Option A, B, or C the donation amount can be reduced. Speak to us if this is something you might consider.

6. Accountability organisations

Please note that ongoing supervision and life-long learning are often requirements in the helping professions and assumed and promoted by accountability organisations. That is why Coram Deo created memberships to, in a cost-effective way (after first completion of the programme) allow practitioners to continue be part of a community and fulfil industry requirements. But since you will be working with the public early on you should register as soon as possible.

Accountability bodies fulfil an important role in all helping professions. CPD points are only valid from date of successful registration at such bodies. Historically, for various reasons, we have advanced two such organisations.

If students are going to work only in the pastoral space then CPSC is important (the Council for Pastoral and Spiritual Counsellors). For narrative practitioners (but not excluding pastoral practitioners) SignoPro is important and is the only accountability organisation where narrative practitioners can register. In many ways they are complimentary. At SignoPro you will receive an initial practitioner number (which is necessary since as part of your supervision you will work with the public), an email (if requested), a webpage you can add your detail on (if requested) and be included in the membership database where the public can verify you.

It is also important for students to register with an accountability body such as CPSC and SignoPro when doing supervision for points (supervision and CPD points) to count from day one. Registration with SignoPro (for Coram Deo students) is straight forward and we suggest students to join at either RC4 or 5. It is also important since students will be working with members of the public.

Once you've registered you can also join the respective learning groups for Supervision and, or, CPD. Further instruction will follow in the month prior to commencement.

10. Commencement

Students will be introduced to supervisors during February, although they can be guided to commence even before that. Thereafter the group will meet for between 18-22 sessions during the year on either a Wednesday morning, Wednesday evening (in Pretoria or simultaneously online), or Tuesday evening in Roodepoort. The individual sessions with supervisors will take place during the year by arrangement between the student and supervisors they choose.

Enrolled supervision students will receive an entire document pack with forms they need (such as for client intake, reflection and more).
